on the third reading, I have no desire to keep the Bill in committee. It can be recommitted if anything important comes up.

Bill reported.

CRIMINAL CODE AMENDMENT

On motion of Hon. C. J. Doherty (Minister of Justice) Bill No. 138, to amend the Criminal Code, was read the second time.

On motion of Mr. Doherty that the House go into committee on the Bill:

Mr. MACKENZIE KING: This is a very long Bill, and I do not think that the minister ought to attempt to go further with it in committee.

Mr. DOHERTY: I would not suggest that we take up anything about which there should be the slightest difference of opinion. There are a large number of clauses; I think quite a number would give rise to no discussion at all, and these we might deal with. It is not impossible that any that develop any very serious objection might be dropped altogether.

Mr. DENIS: The question whether or not a clause is continuous is a matter of opinion. The few members who are here might not think them contentious, but others who are not here might take a different view.

Mr. DOHERTY: I will take the other man's opinion on that point, not my own.

Mr. MACKENZIE KING: I think the minister will make as much progress with his Bill if he does not attempt to go on with it at this hour.

Mr. DOHERTY: Very well.

Motion agreed to, and the House went into committee on the Bill, Mr. Steele in the Chair.

Progress reported.
