## \*VISIT TO PUERTO RICO BY B AND B COMMISSION STAFF

Question No. 1,623-Mr. Rynard:

1. Have any employees of the Royal Commission on Bilingualism and Biculturalism visited Puerto Rico on commission business and, if so (a) how many (b) what was the purpose of these trips (c) what was the cost involved?

2. Is there any connection between the Royal Commission on Bilingualism and Biculturalism and Puerto Rico and, if so, what is that connection?

Mr. P. E. Trudeau (Parliamentary Secretary to Prime Minister): I am informed by the royal commission as follows:

1. Two commissioners and one staff member joined HMCS *Bonaventure* on its recent exercises in the Atlantic, to observe the ship in action and discuss with the officers and men questions relevant to the commission's mandate. This experience was judged desirable by the Department of National Defence, the Royal Canadian Navy, and the royal commission as providing essential background and first hand experience of actual operating conditions for the further research information on the armed services being prepared by the commission's research staff.

The staff member accompanying the commissioners is a research employee in the commission's armed services research group, and was responsible for travel arrangements, liaison with the Department of National Defence and the Royal Canadian Navy, and for recording appropriate information on the experience. Costs were as follows: 2 commissioners, \$463 air fare, \$94.50 expenses. 1 staff member, \$152.70 air fare, \$126.95 expenses.

## CANADA ASSISTANCE PLAN

## Question No. 1,639-Mr. Coates:

1. From what date will the proposed Canadian assistance plan be applicable to assistance schemes implemented by provincial governments?

2. What prior approval is necessary from the Department of National Health and Welfare in order for the provincial governments to qualify?

3. Have discussions been carried out by officials of the Department of National Health and Welfare with regard to the proposed Canada assistance plan and provincial schemes that would qualify for assistance and, if so, in what provinces and on what dates were the provincial schemes passed by the legislatures?

Hon. A. J. MacEachen (Minister of National Health and Welfare): 1. April 1, 1966.

2. The plan will provide for federal-provincial agreements under which the federal government will contribute to the costs of assistance and welfare services provided under provincial legislation listed in the agreements. The provincial programs covered will be those that provide for assistance and welfare services under term and conditions consistent with the Canada Assistance Plan.

3. Yes. Some provinces have legislation of the kind that the plan foresees. The Ontario legislature has before it legislation amending a number of welfare acts. The following provinces have adopted new legislation: Prince Edward Island: Welfare Assistance Act, Royal Assent, April 7, 1966. New Brunswick: Social Assistance Act, Royal Assent, June 10, 1966. Quebec: Medical Assistance Act, Royal Assent, March 31, 1966. Saskatchewan: Saskatchewan Assistance Act, Royal Assent, March 11, 1966. Alberta: Act to
