Hon. John Munro (Minister of National Health and Welfare): 1. 6,884,212 as of October, 1968.

2. If the Government decides to propose an increase in Family Allowances rates, it will be announced in the usual way. With respect to students, allowances are payable, under the federal Family Allowances Program, for children under 16 and thus students are included. The Youth Allowances Program provides for an allowance for young people aged 16 and 17 who are students or who are prevented from attending school by a physical or mental disability. The federal Youth Allowances Program does not operate in Quebec but similar payments are made by the Quebec Government and the Federal Government reimburses Quebec for the cost of such payments.
