Mr. David MacDonald (Egmont): Mr. Speaker, in view of this agreement, because of its importance to the province and the country, and its comprehensive nature, would the minister prefer to make a statement on motions some time next week indicating to some degree the nature and details of this plan?

Mr. Marchand (Langelier): I am willing to consider that, Mr. Speaker, but I cannot make the statement before the agreement is signed.

VIOLENT DISTURBANCES

QUEBEC—USE OF R.C.M.P. TO MEET TERRORIST ACTIVITIES

Mr. Steven E. Paproski (Edmonton Centre): Mr. Speaker, I wish to direct a question to the Solicitor General. I have a very serious question for him arising out of a statement made yesterday in the Quebec legislature by Mr. Lesage, the leader of the provincial Liberal party. Is it a fact, as indicated by Mr. Lesage, that the government of Quebec has declined or at least not requested the assistance of the R.C.M.P. in investigating terrorist attacks in that province?

Hon. G. J. McIlraith (Solicitor General): Mr. Speaker, I have no knowledge of the statements made yesterday in the provincial assembly in Quebec, but it is a fact that the Royal Canadian Mounted Police are cooperating with and assisting both the Quebec Provincial Police and the Montreal City Police.

Hon. Marcel Lambert (Edmonton West): Is the minister in a position to answer the question I asked him two days ago on this area?

Mr. McIlraith: No, Mr. Speaker, I prefer to answer that question on Monday.

NATIONAL DEFENCE

MISSILE SITE IN WINDSOR AREA

Mr. Andrew Brewin (Greenwood): Mr. Speaker, I wish to direct a question to the Minister of National Defence. Inasmuch as Governor Milliken of Michigan has made representations to the government of the United States against the placing of a proposed A.B.M. site near Detroit, and as there is considerable concern in Windsor and vicinity about this whole matter, will the minister look into it and discuss it with his colleague, the Secretary of State for External Affairs, and perhaps make representations to the United States government about it?
