tored by virtue of the fact that the interview leads that person to go and search for work. If that is the case, benefits are restored during the period between the interview and the finding of work. I think that is the proper way to do it.

Mr. Lundrigan: I have another supplementary question.

Mr. Speaker: Order, please. There are a number of supplementary questions, but perhaps the hon. member might be allowed to ask one more.

In view of the fact that people lose their benefits during the period of disqualification even though they are reinstated, and in view of the fact this process has been carried out right across the country—I could give evidence to this effect if I had the opportunity that the minister has on motions—and knowing that this has caused a great deal of hardship, will the minister make a statement on motions again outlining the extent to which he has been able to clean up this blitz process that has caused so much anguish, and also report to the House on the response he has received from the internal inquiry by the board that he said would be able to report yesterday? Would he make such a statement on motions on Monday?

Mr. Andras: Mr. Speaker, I doubt that I will be in a position to make a statement on motions on Monday. I am consulting with the advisory committee on Monday evening, I believe, but I am not sure whether the time of that meeting has been set yet.
