BUDGET SECRECY—SPECULATION IN TV PROGRAM

Hon. Jean Chrétien (Saint-Maurice): Mr. Speaker, in the absence of the Minister of Finance, I should like to direct a question to the right hon. Prime Minister. In light of the very serious speculation on television last night to the effect that there was to be a serious change in the level of corporate taxes in the budget tonight, can the Prime Minister assure the House that the necessary measures were taken for tonight's budget to ensure that there was no leak, because these things can lead to a lot of speculation in the market?

Right Hon. Joe Clark (Prime Minister): Mr. Speaker, the Minister of Finance was concerned about any speculation upon the contents of the budget. He has looked into the matter and he is satisfied that, in fact, all the traditional precautions have been taken to prevent any advance leak of elements of the budget.

Mr. Chrétien: Mr. Speaker, can the right hon. Prime Minister assure this House that there was absolutely no discussion about the level of the increase in gasoline tax that, it is speculated, will be implemented tonight, in view of the fact that the oil industry decided to jump the gun on the government last week and increase its prices before the government in its budget tonight increases the level of prices of gasoline in Canada?

Mr. Clark: Mr. Speaker, I can assure the House and the hon. member that there has been no discussion of the level of any increases although, as the hon. member will know, there has been extensive speculation for some time about price increases of various kinds.

BUDGET SECRECY—NEWS REPORTS ON INCREASE IN PRICE OF GASOLINE

Mr. Mark MacGuigan (Windsor-Walkerville): Mr. Speaker, my question is for the Prime Minister and follows on those asked by my colleague. At the very least there is a general expectation of a hefty raise in the excise tax on gasoline this evening. In light of the very precise news reports this morning that the increase will be 25 cents a gallon, and in light of reports that some service stations across the country—perhaps many—already are raising their prices today in anticipation of this tax increase tonight, can the Prime Minister tell us what steps the government will take to protect consumers in this situation?

Right Hon. Joe Clark (Prime Minister): Mr. Speaker, I am not really quite sure what information that question was designed to elicit. Naturally, I will not comment upon speculative stories which have appeared. I think it would be wise as a general rule in the case of this budget, as in the case of past

That the Government of Canada withhold foreign aid from the government of Tanzania until restitution has been made to Mr. Hassanali and any other Canadian citizen who has suffered confiscation of property and funds at the hands of the government of Tanzania, and that in determining which countries shall receive assistance, Canada's foreign aid policy take full account of unlawful actions perpetrated against Canadians.
