Hon. John Carnell Crosbie (Minister for International Trade): Since the Softwood Lumber Memorandum of Understanding (MOU) was signed on December 30, 1986, the Government of Canada has received 64 communiqués, messages, formal advisories or letters from the U.S. government, commissions and private organizations in the U.S. regarding the MOU.
