PROVINCIAL ELECTIONS
SET DOWN FOR MARCH 3

Legislature Dissolved Yesterday--
Nominations on Feb 25. --- Opposition Ready for Struggle

St. John, N. B., Jan. 23.—The New Brunswick legislature was dissolved yesterday afternoon at 4 o'clock. Nominations will be on Thursday, February 25, and polling day Tuesday, March 3.

In the county of Gloucester, for obvious reasons, polling will be on Monday, March 2.

Members of the government will leave tomorrow morning for St. John and will meet there in the afternoon.

It is understood that Hon. James Barnes will sever his connection with the executive tomorrow.

NICK WALLACE ARRESTED AT TOPSFIELD, MAINE, FOR ANDREW HIGGINS' MURDER

CAULAIS, Jan. 24.—(Special.)—The coroner's jury investigating the death of Andrew Higgins of Baileyville concluded its deliberations late Thursday afternoon, returning a verdict to the effect that the said Andrew Higgins came to his death by foul play at the hands of some person or persons unknown. The body was turned over to Clara Higgins, the deceased's daughter, at the conclusion of the hearing, and was removed to Barnevillie, where funeral services will be held Friday. It will be placed in the receiving vault in Calais until such time as the county officials may permit its interment. Joseph Lovering was an important witness at the inquest. He testified that Higgins, the murdered man, had deposited the sum of \$50 with him for safe keeping on Thursday last and had at that time \$25 in his pockets besides the amount given to Mr. Lovering. The other witnesses were Thos. Sprague, Ben King, and John Munson, the men who found the body on Wednesday morning. Their evidence was practically the same as previously reported.

Nick Wallace, commonly known as Frank Williams, was arrested at Toppsfield, Me. at ten o'clock Thursday morning and brought to Woodland last evening. He was arrested by Otis H. Taylor, first selectman of Toppsfield, and Deputy Sheriff Woodman of Calais and Town Constable John Black of Baileyville brought the prisoner to Woodland for keeping. He will be given a preliminary hearing this morning before trial justice Dudley.

Wallace's coat has blood stains upon it, which he claims were caused by carrying a deer he had killed. A razor, presumably the one used by Wallace from Higgins, the dead man, was offered at the coroner's inquest, the razor being sold by Wallace to Edwin Barnard, the witness who presented it.

Robbing a hen-roost
Interesting Case Heard Before Justice Masson in Fairville Yesterday.

The preliminary examination in the case of The King vs. Edward Bristol, on the complaint of Harry Guiley, Pleasant Point, was continued before Justice Masson yesterday afternoon in the Fairville police court. County Secretary George Vincent prosecuted and J. A. Barry defended.

The complainant in the case was the first witness called, and he told about his henhouse being broken into on Dec. 23rd last, and eight or ten hens stolen.
