PROPOSAL FOR RETALIATORY ACTION IF NEW YORK CONTRACT WITH BOMBARDIER COMPANY IS CANCELLED—MOTION UNDER S.O. 43

Mr. Marcel Dionne (Chicoutimi): Madam Speaker, I rise on a matter of urgent and pressing necessity, under the provisions of Standing Order 43.

Whereas following public tenders, Bombardier, a Canadian company, was awarded a contract for the manufacture of 825 subway cars for the City of New York, and whereas as a result of pressure brought to bear by the Budd Company, the New York Metropolitan Transportation Authority might make use of its right to cancel its contract with Bombardier to award the contract to Budd, I move, seconded by the member for Témiscamingue (Mr. Tousignant):

That if the American authorities cancel their contract with Bombardier, the Canadian government reserve the right to cancel its contract with the American aircraft manufacturer responsible for manufacturing the F-18.

SUGGESTED COMPENSATION FOR USERS OF RENEWABLE ENERGY—MOTION UNDER S.O. 43

That the Minister of Energy be instructed to compensate solar and other renewable energy users at the same level as he compensates the use of expensive and unsure supplies of foreign oil.
