

A Message from the Council by Mr. Gautier :

Mr. Speaker,

The Council have agreed to the Bill, entitled, an Act, for applying certain Monies therein mentioned for the service of the year 1806, and for appropriating such part of the Supplies granted in this Session of General Assembly, as are not already appropriated by the Laws or Acts of the Province.

And then the Messenger withdrew.

A Message from His Excellency the Lieutenant Governor, by Mr. Gautier, Deputy Secretary.

Mr. Speaker,

His Excellency commands this House, to attend his Excellency, immediately, in the Council Chamber.

Accordingly Mr. Speaker and the House, went up to attend his Excellency, in the Council Chamber, where his Excellency was pleased to give his Assent to the several Bills, following, viz. :

An Act, to encourage the raising of Bread Corn, on New Lands.

An Act, to encourage the Fisheries of this Province, by granting a Bounty on the importation of Salt.

An Act, for granting a Bounty on Dry Cod and Scale Fish, exported to his Majesty's Islands, Colonies and Plantations in the West-Indies.

An Act, to regulate the expenditure of Monies hereafter to be appropriated for the Service of Roads and Bridges.

An Act, to regulate the appointment of Collectors and other Officers of Impost and Excise.

An Act, in further addition to and Amendment of an Act, made in the second Year of his present Majesty's Reign, entitled, an Act, for the appointment of Firewards, ascertaining their Duty, and for punishing Thefts and Disorders, at the time of Fire.

An Act, for granting an Annuity to John Newton, Esqr. one of the Collectors of Impost and Excise for the District of Halifax.

After which Mr. Speaker spake as follows :

*May it please your Excellency,*

IT is my duty on the part of the Commons of Nova-Scotia, to present to your Excellency, a Bill, for appropriating the Supplies granted this Session, and to pray your Excellency's Assent to the same.

His Excellency was pleased to give his Assent to the said Bill, following, viz. :

An Act, for applying certain Monies therein mentioned, for the Service of the Year, One Thousand Eight Hundred and Six, and for appropriating such part of the Supplies, granted in the present Session of the General Assembly, as are not already appropriated by the Laws or Acts of the Province.

After which his Excellency was pleased to make the following Speech :

GENTLEMEN,

HAVING no further Business, that it would be expedient to recommend to your consideration at present, I have great pleasure in releasing the Legislature to their own affairs, and hope the result of their long Sessions, will prove beneficial to the Public.

And afterwards the President of his Majesty's Council, by his Excellency's command, said

GENTLEMEN,

IT his Excellency's Will and Pleasure, that this General Assembly, be prorogued to Thursday the Fourteenth Day of May next, to be then here held; and this General Assembly, is accordingly prorogued, to Thursday the Fourteenth Day of May next.
