The question being put on the motion, it was— Resolved in the affirmative.

The Order of the Day being called to resume the debate on the inquiry of the Honourable Senator Deschatelets, P.C., calling the attention of the Senate to the Fourteenth Meeting of the Canada-United States Interparliamentary Group held at Ottawa and Montebello, 16th to 20th February, 1972,

Pursuant to Order, the Senate resumed the debate on the motion of the Honourable Senator McDonald, seconded by the Honourable Senator Forsey, for the second reading of the Bill C-78, intituled: "An Act respecting the use of the expression "Parliament Hill"".

After debate, and— The question being put on the motion, it was— Resolved in the affirmative.

The Bill was then read the second time.

The Honourable Senator McDonald moved, seconded by the Honourable Senator Smith, that the Bill be referred to the Standing Senate Committee on Legal and Constitutional Affairs.
