### RUSSIA—REQUEST FOR STATEMENT RESPECTING EXTENSION OF AGREEMENT

On the orders of the day:

Hon. L. B. Pearson (Leader of the Opposition): Mr. Speaker, may I ask the Minister of Trade and Commerce whether the Russian trade agreement which was about to be renewed a year or so ago is now about to be renewed?

Hon. Gordon Churchill (Minister of Trade and Commerce): The negotiations are still proceeding, Mr. Speaker. I am hopeful that they will be concluded very soon. I have had to give that answer two or three times already this session, but that is the situation as it stands at the moment.

### CANADA-AUSTRALIA—REPORTED SECRET EXCHANGE OF LETTERS RESPECTING QUOTAS

On the orders of the day:

Hon. Lionel Chevrier (Laurier): May I ask the Minister of Trade and Commerce whether there was a secret exchange of letters between Canada and Australia following the signing of a trade agreement between our two countries, wherein Canada is said to have given Australia assurance that she will impose neither quotas nor bans on Australian products even if they cause harm to our farmers, as reported in this week's issue of the *Financial Post*?

Hon. Gordon Churchill (Minister of Trade and Commerce): I have seen the article in the Financial Post. During the course of negotiations leading to the recently signed trade agreement between Canada and Australia a number of letters were exchanged between the two delegations on various detailed matters relating to the agreement and the trade between the two countries.
