TOTAL COST OF WINTER WORKS IN CANADA

Question No. 283-Mr. Caouette:

- 1. What was the total cost of Winter Works Programs in Canada during 1965?
- 2. What is the value of the federal government's contribution?
- 3. Has the government fully discharged this obligation?
- Mr. J. C. Munro (Parliamentary Secretary to Minister of Citizenship and Immigration): 1. Information on the Municipal Winter Works Incentive Program is not compiled on a calendar year or fiscal year basis but rather on the basis of program periods. The federal incentive payment under the program is based on the direct payroll costs incurred on authorized projects, and the total costs of such projects are not reported on claims submitted by the municipalities through the provinces. However, based on estimates provided by the municipalities, the total cost of projects carried out during the program period November 1, 1964 to April 30, 1965 was about \$200,000,000.
- 2. For the program period 1964-65, claims of the municipalities received as at February 3, 1966 totaled \$39,258,753.24. It is estimated that claims amounting to approximately \$1,113,000 have not yet been submitted by the provinces.
- 3. For the program period 1964-65, of the claims received as at February 3, 1966 totalling \$39,258,753.24 payments have been made to the provinces in the amount of \$38,837,364.21. Claims recently received and being processed for payment total \$421,389.03.
