## NORTHERN QUEBEC—TRANSFER OF JURISDICTION OVER ESKIMOS

Has he any report to give on the meetings that have taken place between representatives of the government of Canada and the government of the province of Quebec with the Eskimos? He stated a couple of weeks ago that he expected a report shortly.

**Hon. Jean Chrétien (Minister of Indian Affairs and Northern Development):** Mr. Speaker, I have read the statement that appeared in the press on this matter, and I hope that the policy that the Prime Minister and myself have announced last June, in an effort to ensure equality to all Canadian citizens in accordance with the Canadian Bill of Rights, will be enthusiastically received by all Canadians, including the right hon. member for Prince Albert.
