Has the government promised aid for refugees from East Pakistan and, if so (a) how will it be distributed (b) what agencies will be involved (c) what form will the aid take?

Hon. Mitchell Sharp (Secretary of State for External Affairs): Yes. (a) It will be distributed through Canadian voluntary agencies and the United Nations Geneva Cooperating Group. (b) Canadian voluntary agencies involved are the Canadian Red Cross Society, Oxfam of Canada, Canadian Council of Churches, Catholic Organization for Development and Peace and Mennonite Central Committee. The multilateral agencies are United Nations High Commissioner for Refugees, World Health Organization, World Food Program, UNICEF and the League of Red Cross Societies.
