INCREASE IN GONORRHEA—SUGGESTED EDUCATIONAL PROGRAM AND EXPANSION OF TREATMENT FACILITIES

In view of the alarming statistics on the incidence of gonorrhea in Canada recently reported by the department of National Health and Welfare, has the minister considered instituting an educational program to check the rapid spread of this infection and expanding treatment facilities with the possibility of the use of the new antibiotic, menocycline?

Hon. John C. Munro (Minister of National Health and Welfare): We have noted the statistics to which the hon. member has referred and we have had meetings between the federal and provincial officials to examine the whole area. We think that we have generally worked out satisfactory joint endeavours to cope with the problem.

MURDER AT STE. THÉRÈSE—REQUEST FOR REPORT ON CONDITIONAL PAROLE OF KILLER

Mr. Georges Valade (Sainte-Marie): Mr. Speaker, I should like to put a question to the Solicitor General concerning the murder which happened yesterday in the town of Sainte-Thérèse.

According to newspaper reports, the alleged murderer would have been paroled against his will. Is the Solicitor General aware of that fact and could he tell the House why that individual was released against his will? Does he intend to report to the House in this connection?

Hon. Jean-Pierre Goyer (Solicitor General): Mr. Speaker, the individual was not released against his will. Since August, he had been working outside the institution in a normal way. The fact remains that the day the murder was committed, the Pinel Institute was notified by the Parole Board early in the morning that the parole of the said individual had been rejected.

RESUMPTION OF STUDY OF POSSIBLE ESTABLISHMENT

SUGGESTED FURTHER CONSULTATION WITH FARM ORGANIZATIONS ON STABILIZATION BILL

Mr. S. J. Korchinski (Mackenzie): I should like to direct a question to the minister responsible for the Wheat Board. In light of the fact that the tax reform bill will probably take considerable time in the House, giving the minister ample opportunity to consult the various organizations regarding Bill C-244, has he written or does he intend to write to these organizations so as to enable him to patch up the bill, give it a shot of adrenalin and revive it again in the House in this session?

Hon. Otto E. Lang (Minister of Manpower and Immigration): In the normal course of events I talk very frequently with agricultural organizations and farmers. Certainly I have been hearing from many of them about their desire to see a stabilization program put into effect along the lines of the one that we had before the House. I will certainly give the question of how to move forward with some such program further consideration.

Mr. Speaker: The Chair will recognize the hon. member for Peace River, but I should like to bring to the attention of the House that there are only four minutes left before the end of the question period and hon. members will have to try to limit supplementary questions. Perhaps from now on the Chair might turn an eye toward the senior and distinguished members who occupy the fifth row at the back of the House to allow them an opportunity to ask questions.
