Mr. Morgan: I direct my question again to the Minister of Transport. My question was really aimed at the elimination of tolls, lockage and dockage fees throughout the St. Lawrence Seaway system. Will the minister take under active consideration their elimination?

Mr. Marchand (Langelier): Mr. Speaker, I assume that the hon. gentleman knows that this is part of the law and that normally the seaway is supposed to finance itself. It has never happened in the past, but this is part of the law. It is not an easy question to answer at this time.

ETHIOPIA—GOVERNMENT EFFORTS TO ALLEVIATE EFFECTS OF FAMINE

Mr. Elias Nesdoly (Meadow Lake): Mr. Speaker, I should like to address my question to the Secretary of State for External Affairs. In view of both personal and newspaper reports from Ethiopia that there is famine and widespread starvation there is the minister's department considering some emergency relief to the stricken areas in that country?

Hon. Mitchell Sharp (Secretary of State for External Affairs): Mr. Speaker, the government of Canada, as I have indicated a number of times in response to questions in the House, is already engaged in a massive effort to help the situation in Ethiopia.

LAOS—REASON FOR SEEKING ADJOURNMENT SINE DIE OF INTERNATIONAL COMMISSION FOR SUPERVISION AND CONTROL

Mr. Donald W. Munro (Esquimalt-Saanich): Mr. Speaker, my question is also addressed to the Secretary of State for External Affairs and it concerns the International Commission for Supervision and Control in Laos. Is the minister prepared to tell the House what prompted the government to announce recently its decision to seek an adjournment sine die of the commission. Is it that matters have improved so much there, is it because of frustration, or is it because the commission is no longer effective?

Hon. Mitchell Sharp (Secretary of State for External Affairs): Mr. Speaker, the reason is the final one mentioned by the hon. member, namely, that the commission is not effective, and our concern that we might be asked to take on responsibilities under the new agreement that has been signed in Laos, an agreement which we do not think attracts the obligations that we have under the existing agreement.
