Routine Proceedings

Governments and people are increasingly aware of the fact that security is not a military matter any more and that attention must be paid to economic development and environmental management.

While recognizing that Canada must maintain its active membership within NATO, we recommend that Canada continue to take an active part in the CSCE process and to help build up its conflict prevention centre. We also recommend that Canada join forces with other members of the international community to help the former Soviet republics and eastern European countries dismantle their nuclear arsenal and rebuild their economies. If there is to be sustainable peace in Europe, Canada and the international community as a whole must support these young democracies not only in word, but with positive actions.
