Officials Promise Big Winter Trade

At Meeting Saturday C. A. Hayes, in Charge of Traffic, Informed Citizens That St. John Would Receive All the Steamers it Could Handle.

Representatives of the Common Council and the Board of Trade met with officials of the Canadian government merchant marine at the rooms of the Board of Trade Saturday morning to discuss the inauguration of this port of a line of steamers to be operated by the government. The Mayor and Commissioner Bullock represented the city, and the members of the Board of Trade Council present included R. H. Emerson, chairman of the Board; H. C. Schuchel, chairman of the harbor committee; R. B. Armstrong, secretary, and W. E. Golding, A. H. Wetmore, J. Hunter White, J. A. Likely, W. F. Durbin and G. E. Harbour. The railway officials included C. A. Hayes, vice-president in charge of C. N. R. traffic; D. O. Wood, traffic manager in charge of foreign traffic; R. B. Teakle, general manager of C. G. M. M.; A. J. Gray, local freight agent, and Mr. Weldon.

SOLDIERS PROVED EAGER STUDENTS

Khaki University Achieves Splendid Results With War-Weariness.

Montreal, Sept. 10.—That the Canadian Khaki University had been simply worn out, and had done much to aid soldiers overseas to prepare themselves for the coming battles of peace, was the statement made yesterday by Prof. J. A. Dale, of McGill University, who recently returned from voluntary work with the Canadian Khaki University in Belgium and France. Further, Prof. Dale said, the work of the Canadian Khaki University had been a most useful one. It had led to a general acceptance by the British staff of the principle of educating soldiers in other than military subjects that when they dropped their military drill they were fitted for civil re-establishment, and able to become useful productive citizens. The Canadians had led the way in this, said Prof. Dale, and other troops had followed their lead.

Was Well Worth While.

"Since my return to Canada," said Prof. Dale, "I have often been asked what have been the results of the Khaki University of Canada, as I have seen it work since the armistice. The question has been raised whether it was worth while to attempt any educational service with men, not only in war time, but in the period of 'letting demobilization.' I went over with only the vaguest idea of what I was to do, but convinced that if educational effort was ever worth while it must surely be so in the weary interval between war and peace. This conviction became an ardent wish when, on the invitation of Col. Torry, I began a circuit of the units of the 3rd and 4th Divisions of the Canadian Corps, and then realized the difficulty of grafting an educational organization on one designed for war. These difficulties reduced many to absolute despair. The question now is, was it worth while?"

As to this Prof. Dale quoted a distinguished Canadian officer as saying that no matter what it cost (or how little) it was the best investment the Government could have made. The welcome given these travelling teachers by the officers and men, most of them homesick, weary, and tired of fruitless occupations after hostilities had ended, was wholehearted. The men returned to the training in avidity, and many of them received valuable assistance in the mental training that would free them away from the irresponsibilities of army life, and fit them for civil occupations.

Many Things Taught.

The work varied, said Prof. Dale. Generally it comprised elementary classes, with definite courses in agriculture, motor mechanics, and business subjects. In the majority of units from 60 to 75 per cent of the available men, enlisted in these classes, while the lectures were as well or better attended.

Many of the instructors had assured Prof. Dale that they never had had such eager students as these soldiers, many of whom feared they would never be able to settle down again.

Prof. Dale said that his own experience had been gained visiting the troops through Belgium and France, with all sorts of meetings, from a dozen or two to a thousand or more, in all sorts of buildings from the poorest huts to the grandest hotels. He encountered men willing their
