

Division, Mitschke was posted to "K" Division, Alberta, where he served at St. Albert. On July 11, 1988, he was posted to "A" Division, namely with ERT and SERT, and then on February 1, 1994, he was transferred to Headquarters, namely at the National Operations Centre, where he was still serving at the time of his death.

MONETTE Reg. No. 11754, ex-Sgt. Aimé Roch Georges Monette, 88, died January 24, 1996, at Hemmingford, Quebec. He was born July 4, 1907, at St-Philippe, Quebec, and joined the Force August 17, 1932, at Ottawa. Upon completion of training at "Depot" Division, Monette was posted to "J" Division, New Brunswick, serving at Newcastle, Campbellton, Moncton, Fredericton, Woostock, Perth, Edmundston and St. Quentin, taking his discharge August 16, 1939. He reengaged into the Force October 11, 1939, at Montréal, and was posted to "C" Division, Quebec, serving at Montréal, Bedford and Rouyn. He was subsequently transferred to the following locations: June 19, 1944, to "A" Division, at Ottawa; June 28, 1946, to "J" Division, at Campbellton, Moncton and Fredericton; September 19, 1954, to "C" Division, at Montréal, retiring to pension October 28, 1959. Monette was promoted to corporal November 1, 1952, and sergeant May 1, 1958.

Monette received two Commissioner's Commendations: the first on April 4, 1940, for his work in the seizure of illicit alcohol and three vehicles; the second on September 4, 1942, for his initiative in a search involving the *Excise Act*.

MORIN Reg. No. 13400, ex-S/Sgt. Rosaire Napoléon Roger Morin, 76, died March 10, 1996, at Saint-Jean, Quebec. He was born April 14, 1919 at Quebec City, where he had joined the Force April 30, 1940. Upon completion of training at "Depot" and "N" Divisions, Morin was posted to "C" Division, Quebec, where he worked at Montréal, Mégantic, Chicoutimi, Roberval, Caughnawaga and Drummondville, retiring to pension June 28, 1963. Morin was promoted to corporal May 1, 1948; sergeant May 1, 1957, and staff sergeant November 1, 1959.

On September 10, 1948, Morin was awarded the Commissioner's Commendation for his excellent investigative work resulting in the seizure of a large quantity of illicit alcohol and vehicles.

MULCASTER Reg. No. 12621, ex-S/Sgt. Richard Mulcaster, 81, died February 7, 1996, at West Vancouver, British Columbia. He was born March 31, 1914, at Prince Albert, Saskatchewan, and joined the Force June 24, 1935, at Regina. Upon completion of training at "Depot" Division, Mulcaster was posted to "K" Division, Alberta, where he worked at Edmonton, Field, Canmore, Calgary, Wetaskiwin, Smoky Lake, Westlock, Fort McMurray, Cadomin and Ryley, retiring to pension July 4, 1958. Mulcaster was promoted to corporal November 1, 1946; sergeant May 1, 1953, and staff sergeant November 1, 1956.

PAUW Reg. No. 32459 (S/672), ex-Cst. Tom Peter Pauw, 45, died February 23, 1996, at Chilliwack, British Columbia. He was born October 17, 1951, at Stockholm, Sweden, and joined the Force as a special constable March 6, 1973, at Toronto, Ontario. Upon completion of training at "Depot" Division, Pauw was posted to "O" Division, Ontario and worked at the Toronto International Airport. On March 31, 1975, he converted to a regular member status and upon completion of training, he was posted to "O" Division, where he worked at Toronto. On June 24, 1977, Pauw was transferred to "E" Division, British Columbia, and served at Burnaby and Vancouver, taking his discharge October 12, 1994.

PECK Reg. No. 14237, ex-S/Sgt. Thomas Joseph Peck, 77, died April 3, 1996, at Marion Bridge, Nova Scotia. He was born August 5, 1918, at Louisbourg, Nova Scotia, and joined the Force August 20, 1941, at Halifax. Upon completion of training at "Depot" Division, Peck was posted to "F" Division, Saskatchewan and served at Regina and Broadview. On January 1, 1943, he was transferred to "G" Division, namely at Whitehorse (Yukon), and on October 31, 1946, he was transferred to "F" Division, Saskatchewan, where he served at Regina, Saskatoon, Biggar, Kindersley, Rosetown, Elbow, Vonda, Eston, Maple Creek and Lloydminster, retiring to pension November 27, 1968. Peck was promoted to corporal May 1, 1955; sergeant May 1, 1962, and staff sergeant November 1, 1963.

PORTER Reg. No. 35542, Cst. Glenn Wayne Porter, 37, died February 7, 1996, at St. John's, Newfoundland. He was born December 16, 1958, at Cornerbrook, Newfoundland, and joined the Force September 11, 1979, at Halifax, Nova Scotia. Upon completion of training at "Depot" Division, Porter was posted to "B" Division, Newfoundland, namely at Holyrood, Burin, Marystown, Happy Valley/Goose Bay and Stephenville, where he was still working at the time of his death.

POWROZNIK Reg. No. 21661, ex-Cpl. Robert Vinson Powroznik, 54, died February 13, 1996, at Richmond, British Columbia. He was born July 3, 1941, at The Pas, Manitoba, and joined the Force November 16, 1960, at New Westminster, British Columbia. Upon completion of training at "Depot" Division, Powroznik was posted to "F" Division, Saskatchewan, and served at Swift Current, Maple Creek and Regina, taking his discharge November 15, 1965. Powroznik reengaged into the Force July 20, 1967, at New Westminster, and was posted to "E" Division, British Columbia, namely at Burnaby, Dawson Creek, Hazelton and Richmond, retiring to pension September 8, 1992. He was promoted to corporal August 8, 1978.

SCHRYER Reg. No. 0.991 (20346), Supt. Jean-Jacques Pierre Schryer (retired), 56, died February 24, 1996, at Cumberland, Ontario. He was born June 3, 1939, at Hull, Quebec, and joined the Force February
