Mr. Speaker,

The Council have agreed to a Bill, entitled, An Act for the encouragement of the Cod and Scale Fisheries of the Province, without any amendment.

And then the Messenger withdrew.

The House proceeded to the consideration of the amendments made by the Council, to the Bill in, addition to the Act for the repairing, keeping in repair, cleaning and paving, the Streets in the Town and Peninsula of Halifax, and the same were read throughout a first and second time, and thereupon,

Resolved, That a conference be desired with the Council, on the subject matter of the said amendments, and that the Clerk do request the same.

The Clerk reported that the Council had agreed to the conference, as desired by the House.

Ordered, That Mr. Pryor, Mr. Archibald and Mr. Haliburton, do manage the said conference.

And they went to the conference.

And being returned,

Mr. Pryor reported that the Managers had been at the conference; and stated the substance of the conference to the House.

Resolved, That the Bill do pass, and that the title be, An Act for applying certain Monies therein mentioned, for the service of the year of our Lord one thousand eight hundred and eighteen, and for appropriating such part of the Supplies granted in this Session of the General Assembly, as are not already appropriated by the Laws or Acts of the Province.

Ordered, That the Clerk do carry the Bill to the Council, and desire their concurrence.
