British Columbia Elections.
NEW WESTMINSTER, March 8.—E. C. Baker and Noah Shakespeare (Con-
servatives) were re-elected to-day to
represent Victoria in the House of
Commons.

An Election Fiasco.
BELLEVILLE, March 8.—Richard
Arnott, who left the city after election
day to avoid arrest, was fined \$35 by
the magistrate to-day for assaulting
several Reform voters.

Canadians in Chicago.
The first annual reception concert
and ball of the Chicago Canadian Club
was held on the evening of the 22nd
Feb. last, in Chicago. On the recep-
tion committee was Dr. H. O. Bates,
an old Leeds County boy, who has now
a fine practice in that city.

A Worthy Retic.
MR. R. F. Cheeky, of North Au-
gusta, has in his possession a sword
which was successfully carried through
the battle of Waterloo by his uncle,
Mr. John Gowans. Mr. Cheeky prides
it dearly, and says that he would not
part with it under any consideration.

The Intercolonial Railway.
The Montreal Herald says:—"The
Intercolonial Railway, under the man-
agement of the Hon. John Henry
Pope, is as we have said before, a bot-
tomless pit of iniquity. The man-
agement is disgraceful beyond all pre-
cedent. The abuses cry to heaven.
The road is simply a political engine,
conducted at an enormous loss to the
country, manipulated so as to increase
the Government's hold on power."

A Royal Temple Defaulter.
BUFFALO, March 10.—E. H. Abbott,
the Supreme Secretary of the Royal
Temple of Temperance, is a defaulting
to the extent of \$5,000. He
lived, with his wife and two children,
at Aurora, but was in Buffalo
every day. As Supreme Secretary he
received \$25,000 per month in dues,
and this he was required to pay over
daily to the Treasurer, John Lyth, of
this city. Abbott received a salary of
\$3,000 a year, and had been Grand
Secretary for several years.

Important Scott Act Decision.
TORONTO, March 7.—A very impor-
tant decision was given on Saturday
by the Chancery Division Court,
in the case of the Queen vs. Fee, un-
der the Scott Act. The point decided
in this case is one of great importance,
and shortly stated is, that under sec-
tion 128 of the Canada Temperance Act,
by which the accused is made a com-
petent and compellable witness, he is
not bound to criminate himself. The
identical point was decided in the
same way by the Supreme Court of
Prince Edward Island in the Queen
vs. Connolly, 4 Canadian Law Times,
801, but the Chancery Division has
now reached an opposite conclusion,
as it holds that the deft. in a Scott
Act prosecution is bound to answer,
even though by so doing he criminate
himself. This will of course, be a
great aid to persons engaged in work-
ing out the Scott Act, as it will ren-
der convictions much easier. From
this decision there is no appeal, so
that the law may be taken as settled,
unless some adventurous person man-
ages to bring the matter up on habeas
corpus before the Court of Appeal.
The Chancellor who delivered the
judgment of the Court, dealt very
eloquently with the subject, justifying
the decision upon English authority.
He pointed out that it was one of
Bentham's theories of law, that if the
accused should be compelled to testify
against himself, and quoted a remark
of his upon the maxim *nemo tenetur
seipsum accusare*, to the effect that if a
number of burglars and highwaymen

busy to undertake all the mischief
wanted, in which case a portion of it
is executed by the firm of Ralph
Heaton & Sons, Birmingham; in
such instances coins have the letter
"H" stamped upon them. Collec-
tors have noticed that the coins turned
out by this firm are usually better in
workmanship than those made at the
mint itself.

Quarrelling Over Mr. Beecher.
CHICAGO, Mar. 7.—A most extra-
ordinary scene took place at the weekly
meeting of the Congregational minis-
ters this morning. A topic which
naturally came up was the sickness
from which Henry Ward Beecher is
believed to be dying. The sentiment
of some of the pastors present took
the shape of resolutions of condolence
which it was proposed to send to Mrs.
Beecher by telegraph. This was bit-
terly opposed by a number of the
ministers, their opposition being based
on the alleged heterodoxy of Mr.
Beecher's views regarding salvation
and future punishment. An acrimo-
nious debate ensued, and finally the
motion to adopt the resolution was
lost.

The Great Frencher Dead.
NEW YORK, March 8.—The Rev.
Henry Ward Beecher died to-day at
9:30 a. m. He did not regain con-
sciousness from the time of the first
attack. As he neared the end and
approached the family could be heard weeping and
sobbing. Dr. Beattie stood by the
bedside holding one of Mr. Beecher's
hands, and at 9:30 he said, "Mr.
Beecher is no more; he is dead." It
is difficult to describe the scene at
this moment. Notwithstanding the
fact that his death was looked for,
that it had been expected hourly, it
seemed to come with such crushing force
that the family were prostrated with grief.
Mrs. Beecher who had held up so
bravely from the first, was utterly
broken down, and when supported by
her son Harry as he tottered from the
room, looked as if it would not be
long before she would follow her be-
loved husband. The news of Mr.
Beecher's death spread very quickly
to all parts of the city, and Brooklyn
may now be said to be a city of mourn-
ing.

A Fearful Tragedy.
The following is stated to be a cor-
rect account of the recent tragedy at
Grand Falls, N. B.—Two traders
named Blake and Kelly have been in
the habit of selling goods in the vicin-
ity. When they last left there was
some trouble with a note, and a man
named Searway swore that if ever
Blake came back he would beat the
life out of him. On the 21st ult.
Blake and Kelly returned and went
into a public house. Seated in the
room were two Frenchmen and short-
ly after Searway entered. The French-
man called on him to carry out his
threat against Blake. Searway was
afraid to attack Blake openly and
going behind his back picked up a
poker and struck him on the head knock-
ing him senseless. Then he picked up
the body, and jumped on it until Kelly
interfered to save his partner from
being murdered. Then the French-
men jumped upon Kelly. Searway al-
ways turned on him, and catching him
up, threw him over the table, and
jumped upon his chest until it was
pulp. Help came and Searway and
the Frenchmen fled. The beaten men
were taken to the Grand Falls Hotel,
where two days later, Kelly died of
his injuries, and even now Blake lies
at the point of death. Searway has
been arrested.

formed an association for the purpose
of furthering the interest of their
profession, *nemo tenetur*, &c. would
naturally be the first rule or by-law
they would pass.

Riel's Coadjutors.
Michael Dumas, who escaped from
the Northwest after the rebellion, in
company with Gabriel Dumont, and
is residing with his family at St.
Charles, near Winnipeg, before the
amnesty was granted, was living near
the boundary, and afterwards rejoined
his family. He gives an interesting
description of the trip of Dumont and
himself from Batoche to Fort Bell-
knop, which occupied eleven days.
They lived most of the time on ante-
lope they shot during the trip. They
never saw a white face, as they kept
out of the district where civilization
was likely to exist. After their re-
lease by the American authorities Du-
mas worked for a time on a rancho at
Lewiston, Montana, while Dumont
maintained himself by hunting. Then
came the offer to join Buffalo Bill's
Wild West Combination, which Du-
mas declined and Dumont accepted.
During his separation from his family
Dumas says four of his children died,
while Dumont lost to say much about
Riel, but thinks the cause of the
Halfbreeds just. He thinks the Gov-
ernment should make him some com-
pensation for what he lost.
