FORMER EMPLOYER COMES TO AID OF ACCUSED MOTHER

Furnishes Bail and Employment for Baby Deserter.

DID IT FOR LOVE ONLY

Girl Tells Court She Could Not Support Self and Child.

Admitting that she abandoned her babe on Sept. 15 by leaving it in the Grand Trunk car, Dorothy Suchick, arrested in Toronto on Tuesday night at the request of the London police, was charged with the charge of leaving the child in the hands of a stranger when she appeared before Magistrate J. C. Judd in police court today.

The girl, mother, who gave her name as Dorothy Suchick, alias "Larley," her story to the court, was that she was a victim of a man who was a deserter from the army and who had been in the hands of the police.

The girl formerly worked in London, and her ex-employer came to her rescue and furnished her with a home and employment for her pending the action of the courts.

The magistrate refused the girl's request for possession of her child again, and in the meantime it will remain in the hands of the girl's mother, where the child was being discovered in the G. T. R. Detroit express, which arrived here at 4:10 on the afternoon of September 15.

Police investigations substantiate the girl's story that it was only her circumstances that led her to abandon the baby.

Turned Back at Border.
The girl was working in Toronto as a telephone operator some weeks after the birth of her child in that city. She was advised by her mother to go to Detroit, where she could earn enough to support both herself and the babe, but the American immigration authorities refused her permission to cross the border with her nameless child.

Starting again for Toronto, she says, her trouble preyed on her mind that when she reached London she left the child on the G. T. R. train and went to Toronto via C. P. R. In the Queen City, she again received her former employment as a telephone operator.

In appearing in court today, her former London employer declared that while here she had been regarded as a fine type of young woman.

"The girl is more to be pitied than censured," he declared. "Because she has taken this one wrong step, there is no reason why she should not be given another chance, and I am going to do what I can for her."

VON TRITZ ACCUSED OF LIES TO BOOST UP SUB CAMPAIGN

Professor Valentin Declared That Admiral Misled Reichstag as to Number of Craft and Amount of Tonnage Destroyed—Germany Stirred by Feud.

[Canadian Press.]

Berlin, Sept. 20.—(Press.)—Renewed and full discussion in the Reichstag of the submarine issue and the controversy between Admiral von Tirpitz and the navy, appears to be inevitable in consequence of the publication yesterday of the letter exchanged between Chancellor von Bethmann-Hollweg and the admiral.

From these letters the public learned that in a private conversation Professor Valentin, assistant admiral von Tirpitz, had misled the Reichstag in regard to the number of available submarines and the possibility of a submarine campaign.

Refuses to Revoke Him.
The admiral demanded that the chancellor discipline Prof. Valentin, but the chancellor, in the position that the professor was not subject to his disciplinary powers.

These letters, however, touched only the fringes of the controversy, which for months have been circulating from mouth to mouth in connection with this controversy. The only statement that Admiral Tirpitz furnished incorrect figures regarding the number of available submarines, which charges were denied by the admiral, but also the declaration that the admiral deliberately misled the Reichstag and the chancellor regarding the previous success of the submarine campaign.

PLOT TO ASSASSINATE VENIZELOS BY GERMANS
New York Paper Claims Attempt Was Actually Made.

NATIVE OF FLESHERTON HE COULD NOT WORK
John W. Bates, Undertaker, Dies in Toronto.

TORONTO, Sept. 20.—After a long illness John W. Bates died on Wednesday morning at his residence, 124 Avenue road. Mr. Bates was born at Flesherton, Ont., 63 years ago. After being in the undertaking and furniture business there for many years, he came to Toronto, and was a partner in the firm of Bates & Dodds. Five years ago he established the firm of the Bates Burial Company. For the last three years he had been unable to engage in active business life. He was a member of the Western District Orange Order of Toronto. His only son, predeceased him eight years ago, and Mr. Bates never fully recovered from the shock of his tragic death. A widow and one daughter, Mrs. Richard Madocks, survive him.

Reaches Bavarian King.
This account of Prof. Valentin's conversation not only reached Admiral von Tirpitz, but was submitted in the form of an affidavit to the Bavarian war ministry and formed one of the subjects of discussion at an audience granted last month by the king of Bavaria to a delegation which demanded a change in the imperial policy, and the sharpest possible warfare against Great Britain.

In a communication printed in the Nord Deutsche Allgemeine Zeitung this afternoon Prof. Valentin denies the charges of misstatement, or that he charged in the affidavit, or that he authorized this statement the chancellor, with whom at that time he was not acquainted. There has arisen a question of veracity between Prof. Valentin and the author of the affidavit, Prof. Crossman, editor of the South German Monthly, a prominent political journal.

The partisans of the admiral and of the chancellor, the protagonists of the ruthless submarine warfare and the United States, have thrown themselves into the controversy, and by the time the Reichstag convenes ample material for a vigorous clash doubtless will be available.

ADVOCATES CENSOR FOR ADVERTISING IN NEWSPAPER COLUMNS

Prominent Ad. Men Favors This in Address.

CUT OUT UNTRUTHS

Objectionable Ads. Harm Those of Legitimate Character, He Tells Club.

W. H. Bramble, advertising manager of the Goodbye Tire Company of Canada, was the speaker at the opening autumn luncheon of the London Advertising Club, in the Westminster House, last night. His subject was "Objectionable Advertising." There was a good attendance.

Not all untruthful advertising was necessarily objectionable, said Mr. Bramble, but if all the untruthful advertisements were eliminated from the newspapers about 90 per cent of the objectionable advertising would be gone. He said that the newspapers were more than ever before, and he was a business. The same expenditure of money nowadays does not produce the results it formerly did. There was more competition. Some times needed more advertising than others, as there was an unlimited field. Others had their field limited. There was a certain extent, making it harder to get the business the advertiser wanted.
