

# OFFICIAL DEVELOPMENT ASSISTANCE DISBURSEMENTS BY DEPARTMENT FOR 2015-2016

The Government of Canada disbursed \$4.82 billion in Official Development Assistance (ODA) in 2015-2016 through 17 federal departments and agencies. Final and detailed financial information for 2015-2016, including for bilateral and multilateral assistance,<sup>1</sup> will appear in the *Statistical Report on International Assistance (Fiscal Year 2015-2016)*, which will be available on the Global Affairs Canada website by the end of March 2017. Table 1 describes the amount disbursed by each of the 17 federal departments and agencies, along with which key commitments and ODA thematic priorities these funds addressed.
