Would the Secretary of State consider the matter?

Hon. J. W. Pickersgill (Secretary of State): Mr. Speaker, I welcome any suggestion that would lead to a saving of time, but this was a change made by the committee on procedure when the hon. member was not a member of the house. I regret the change, but it was made. However, if we could have unanimous consent to set up the committee on procedure perhaps we could get a few of these changes, including the admirable change suggested on a number of occasions by the Leader of the Opposition when he was prime minister, that questions on the orders of the day should be limited to half an hour, to which the official opposition of that time agreed.

Right Hon. J. G. Diefenbaker (Leader of the Opposition): Mr. Speaker, since the hon. gentleman, with his customary disregard of the rules, has brought me into the picture, let me say that hon. gentlemen opposite were the

ones who brought about the expansion of the asking of questions in the house. They were the wrongdoers, and now they object to that which they themselves created.

Mr. Chevrier: What about your disregard of the rules?

Right Hon. L. B. Pearson (Prime Minister): Mr. Speaker, since the Leader of the Opposition has made this statement, it should be made perfectly clear that the limitation of questions to 30 minutes was agreed to by us when we were in opposition, and was not agreed to by the then prime minister.

Mr. Speaker: Order. I am sure we do not want to extend the question period beyond four o'clock. The hon. member for—

Mr. Diefenbaker: Mr. Speaker, I cannot allow that statement to go unchallenged. It is without any basis in fact.

Mr. Pearson: Mr. Speaker, seeing that the Leader of the Opposition has made that statement, perhaps the leaders of the other two parties who were concerned with the negotiations at that time might have something to say on the matter.

Mr. Knowles: I apologize for making a suggestion to save time. Obviously such a suggestion only results in our losing time.

Mr. Speaker: I wish to accept the suggestion of the hon, member for Winnipeg North Centre.
