1. Prior to premature release and as part of the reduction of the armed forces, were officers asked to volunteer for premature release with a cash bonus as an incentive?

2. If not, for what reason?

3. Is the policy of premature release of officers with a cash bonus completed? 4. If so, has this been officially promulgated to

all officers?

Hon. Paul Hellyer (Minister of National Defence): 1. No.

- 2. Officers who were released prematurely with financial benefits were selected for such release based on certain criteria which permitted the services to retain control of those considered for release.
- 3. Yes, P.C. 1964-15/1239 dated 13 August, 1964, terminated on 6 May, 1966.
- 4. Personnel in the rank of army captain (and equivalent) and below, including all non-commissioned personnel, were notified in May 1965 by general message. Other officers affected were notified individually.

Has the naval board in the national defence structure been discontinued and, if so (a) what was its role and purpose (b) on what date was it disbanded (c) what has replaced it?

Hon. Léo Cadieux (Associate Minister of National Defence): Yes. (a) the formulation of naval policy and the co-ordination of the activities of all branches of the Royal Canadian Navy; (b) 1 August, 1964; (c) chief of defence staff and branch heads.

RETIREMENT REQUESTS BY SERVING OFFICERS

Question No. 1,907-Mr. Forrestall:

Have any serving officers of the Canadian armed forces written to defence headquarters since June, 1965 asking that they be retired without loss of pension aid, if so (a) how many (b) how many such requests have been granted?

Hon. Paul Hellyer (Minister of National Defence): Yes, however personnel statistics do not record the information asked in (a) and the necessary expert staff is not available to undertake the large amount of work which would be required to gather the necessary information; (b) between June 1, 1965, and August 31, 1966, 259 officers were released without loss of pension/annuity. However, in some instances there would be a reduction
