#### TAXATION ON MUNICIPAL BONDS REVENUE

## Question No. 2,244-Mr. Fortin:

1. Is the government considering, has it considered or will it consider, tax exemption for revenue derived from municipal bonds?

2. What does the government propose to do to help financing municipal corporation capital expenditures?

Hon. E. J. Benson (Minister of Finance):
1. This is a matter of Government policy.
If the Government proposes any exemption
for income received for municipal bonds, it
will be announced at the appropriate time.

2. The Government of Canada proposes to maintain a fiscal and monetary policy which will reduce inflationary pressures on the capital market, and enable it to provide capital for economic development and for the social needs of the Canadian people. Where social needs are of compelling priority, as in the case of public housing and municipal sewage treatment, the government will continue to make funds available at less than market cost through CMHC.

Indirectly, the federal government makes substantial amounts of capital available, at rates based on the yield of Government of Canada bonds, through purchases by the Canada Pension Plan Investment Fund of provincial, or provincially-guaranteed securities. Where the provinces feel it is appropriate, these funds are used to assist in municipal financing. In 1968-69 the amounts made available to provinces from this source were:

## ALTERNATIVE EMPLOYMENT FOR POST OFFICE

Could the Minister of Communications inform the House if any definite steps are being taken to provide alternative employment for persons whose jobs are being or have been eliminated by the recent Post Office reorganization?

Hon. Eric W. Kierans (Postmaster General and Minister of Communications): In so far as the Post Office Department is concerned: It is assumed that this question refers to the institution of five-day week delivery service. To prepare for the reduction in staff as a result of this change the Department for several months did not fill vacancies on a permanent basis and thus created a backlog of vacant positions. Through this action it will be possible to absorb those employees whose positions were eliminated through the five-day service.

# PROVINCIAL APPEAL BOARDS IN ASSISTANCE PLAN
