DAIRY INDUSTRY—SUBSIDIES PAID TO DAIRY PRODUCERS

Question No. 250-Mr. Lambert (Bellechasse):

- 1. What is the amount of the subsidy paid by the Canadian Dairy Commission to commercial milk producers between April 1, 1969 and August 31, 1969?
- 2. What amount was deducted from the subsidy for export duty during the same period?
- 3. What amount was deducted from the subsidy by virtue of the .52¢ per 100 lb. tax for production exceeding quotas?
- Hon. H. A. Olson (Minister of Agriculture):
 1. Net subsidy payments to milk and cream shippers, after deductions of holdbacks for export equalization costs, covering deliveries reported for the months of April to August, inclusive, totalled \$44,350,000.
- 2. Deductions for export equalization costs on account of deliveries during the period were \$13,022,000.
- 3. Deductions by virtue of the 52 cent holdback on milk deliveries in excess of quota are not recorded separately.

AIR POLLUTION—AUTOMOTIVE CONTROLS

Hon. Ron Basford (Minister of Consumer and Corporate Affairs): 1. The Director of Investigation and Research under the Combines Investigation Act is aware of the proceedings in the United States. In accordance with the usual practice, any information of this nature coming to the attention of the Director is carefully considered to determine whether he has reason to believe there has been an offence against the Act so as to warrant formal inquiry. The practice is, however, that no information is given out as to whether an inquiry is being pursued with respect to a particular group of companies unless and until a report is published or proceedings are instituted in the Courts.

INVESTIGATION INTO PRICE FIXING BY NEWSPRINT COMPANIES

Is the Combines Investigation Branch undertaking an investigation into the recent announced identical price increases on newsprint to determine possible price fixing among the newsprint companies and, if so, what are the results of this investigation and what action is contemplated?

Hon. Ron Basford (Minister of Consumer and Corporate Affairs): It is the policy of the Director of Investigation and Research under the Combines Investigation Act to scrutinize all significant price movements which come to his attention and he is charged with the responsibility of initiating an investigation whenever he has reason to believe there has been no offence against the Act. It is the practice, however, that no information is given out as to whether an inquiry is being pursued with respect to a particular group of companies or individuals unless and until a report is published.
