The Canadian Economy

Mr. Lundrigan: Fullblooded Canadians. The matter involves the August unemployment rates released today showing, in actual numbers, 455,000 Canadians unemployed, the highest number for the month of August since the beginning of the compilation of statistics by DBS in 1946. Because of the obvious urgency of this problem, coupled with other economic indicators which show dramatically the current critical state of the economy, I should like to move the following motion, seconded by the hon, member for Vegreville (Mr. Mazankowski):

This House directs the government to immediately launch a series of initiatives explicitly and purposely aimed at the amelioration of the domestic economic problems facing this nation, and that these initiatives include the preparation of a massive winter works program, and that the energies of all related government departments be directed toward this end in an effort to alleviate what will otherwise become the bleakest winter in recent Canadian history.

Mr. Speaker: Hon. members have heard the motion proposed by the hon. member for Gander-Twillingate. Is there unanimous consent?

Some hon. Members: Agreed.

Some hon. Members: No.

Mr. Speaker: There is not unanimity and the motion cannot be put.

MEASURES TO STIMULATE—REQUEST FOR UNANIMOUS CONSENT TO MOVE MOTION UNDER S.O. 43

That in view of the dismal prospects for the coming winter, forewarned in the statistics released this morning, this House urges the government to bring forward immediately measures to stimulate the economy to prevent a repetition of the high levels of unemployment experienced last winter.

CRIMINAL CODE

AMENDMENT PROVIDING FOR DISMISSAL OF CHARGES ONE YEAR AFTER STAY OF PROCEEDINGS DIRECTED

Mr. Andrew Brewin (Greenwood) moved for leave to introduce Bill C-266, to amend the Criminal Code (stay of proceedings).

Some hon. Members: Explain.

Mr. Brewin: Mr. Speaker, the purpose of this bill is to provide, where provincial Attorneys General direct a stay of proceedings in a criminal case, that after a year's lapse the charges shall be deemed to have been dismissed. The purpose is to remedy the situation revealed recently in the province of Quebec where the Attorney General of that province entered a stay of proceedings against 36 persons charged under the War Measures Act or the Public Order (Temporary Measures) Act, and it was claimed that the effect of this action was that the charges could be revived at any time and thus hung over the heads of the persons accused indefinitely without giving them a chance to prove their innocence. The proposed amendment, Mr. Speaker, was recommended a year ago by the Canadian Bar Association.

Motion agreed to, bill read the first time and ordered to be printed.
