- 3. What areas in each province have been chosen as locations for implementation of the development phase of the community employment programmes?
 - 4. What is the projected cost of the development phase for 1975-76?
- Hon. Robert K. Andras (Minister of Manpower and Immigration): 1. None as such. However, there will be already established government programmes which will participate and form a part of a community employment strategy.
- 2. Approximately 100 per cent, since C.E.S. is aimed at those people who are continuously unemployed and who rely on welfare or unemployment benefits for income.
- 3. British Columbia: Nanaimo and Kamloops; Saskatchewan: Target group of about 1,500 people within the province who are considered employable welfare recipients. Agreements with other provinces are still being negotiated.
 - 4. \$15 million.

LIST OF CHARITABLE ORGANIZATIONS

Question No. 1,783-Mr. Munro (Esquimalt-Saanich):

Is there a list available of the incorporated causes or institutions deemed, for the purposes of the Income Tax Act, to be charitable institutions and, in consequence thereof, authorized to issue receipts for income tax purposes enabling donors or contributors to claim contributions as deductible expenditures and (a) if so, where is it to be found (b) if not, would it be provided?

Hon. Ron. Basford (Minister of National Revenue): Yes. The Department prepares an annual computer listing of all registered Canadian charitable organizations, corporations and trusts, donations to which are deductible for income tax purposes. Listings of additions and deletions are prepared quarterly. (a) These listings which are approximately four inches in thickness are not distributed to the public although they are made available in the District Taxation Offices for public perusal during normal working hours. (b) Not applicable.

*ELECTRONIC MEDIA COVERAGE IN HOUSE OF COMMONS

Question No. 1,790—Mr. Gauthier (Ottawa-Vanier):

- 1. To the knowledge of the government did the British House of Commons have a free vote on the electronic media coverage of their debates?
- 2. When the resolution to allow some form of electronic media coverage is moved in the Canadian House, will the government allow a free vote on this most important question?
