POSSIBILITY OF MAKING SHIPMENTS THROUGH UNITED STATES IN VIEW OF STRIKE AT VANCOUVER

Mr. Peter C. Bawden (Calgary South): Mr. Speaker, my supplementary is for the minister in charge of the Wheat Board. In view of the severe hardship to western farmers in the agricultural community, I would like to ask him whether his department has investigated making these shipments by way of the United States until such time as the problems in Canada are settled, and if not, why not?

Hon. Otto E. Lang (Minister of Justice): Mr. Speaker, we have frequently considered many contingency plans. It happens, however, that the ordinary system of shipping Canadian wheat out of the west coast is to move it in an uncleaned condition to the terminals and clean it there. The typical terminals which might be available in the United States do not have cleaning capacity, and therefore it is not a practical suggestion.

FARM LABOUR—AVAILABILITY OF OFFSHORE WORKERS IN VIEW OF GOVERNMENT POLICY GIVING PRIORITY TO CANADIANS

Mr. J. Larry Condon (Middlesex-London-Lambton): Mr. Speaker, I would like to direct my question to the Minister of Manpower and Immigration. Is the minister aware of the dilemma farmers are facing because of the government policy of hiring Canadian workers before offshore workers and Mexican help? If so, can he give hon. members of this House some direction in how manpower centres can make these offshore workers available to farmers since Canadians will not work in these areas?

Hon. Robert K. Andras (Minister of Manpower and Immigration): Mr. Speaker, with respect, I think the premise is not totally correct. We are certainly directing our attention to the priority of searching for Canadians available for work in Canada before we enlist the services of people from other countries. This program should be very well known to farmers in southern Ontario because of the many releases which have been made and the many consultations we have had. We can assure them that there will be labour, but we are determined to search and find Canadians first as the first priority before we resort to bringing in offshore workers.

HOCKEY—SUGGESTION AMATEUR ASSOCIATIONS NOT SIGN CHILDREN TO CONTRACTS—GOVERNMENT ACTION
