INQUIRY WHETHER DRUG PRICES WILL INCREASE

Monday, when he answered my question about the \$100 million granted to the provinces, the Minister said: "I can assure you, Mr. Speaker, that the \$100 million way more than covers any additional costs"...! Mr. Speaker, that is an admission that prices will increase. Yesterday, in answer to the same question put by my colleague, the Hon. Member for Sudbury, the Minister said: "I hope he was careful to listen to what I have been saying all along, that the price of drugs will not go up by a penny." Could we have the truth, once and for all? Are prices going to go up, yes or no?
