Hon. Mr. Connolly (Ottawa West): Honourable senators, I move, with leave of the Senate, that when the Senate adjourns today it do stand adjourned until Tuesday, January 31, 1967, at 8 o'clock in the evening.

Hon. Mr. Brooks: May I ask the honourable Leader of the Government when the House of Commons will resume after the Christmas adjournment, and also what we may expect in the way of legislation when we return on January 31?

Hon. Mr. Connolly (Ottawa West): It is my understanding that the House of Commons will adjourn until January 9, but I cannot say what that chamber will produce in way of work for us between the 9th and 31st days of January. The Transport Bill is now engaging the attention of the other place, and perhaps it will be the first piece of legislation that we shall consider in the New Year. The Bank Act is on the Order Paper, and I think there are three measures that have emanated from the Special Joint Committee on the Public Service. Besides these, there is other legislation, some of which may be passed by the other place before we re-assemble.

Motion agreed to.
