place, and whether or not any bodily injury is effected, is guilty of felony, and shall be liable to be imprisoned in the Penitentiary for any term not exceeding fourteen years and not less than two years, or to be imprisoned in any other gaol or place of confinement for any term less than two years, with or without hard abour, and with or without solitary confinement.

30. Whoseever sets or places, or causes to be set or placed, Setting spring any spring-gun, man-trap, or other engine calculated to destroy guns, do. the an life or inflict grievous bodily harm, with the intent that inflict grievous bodily harm. the same or whereby the same may destroy or inflict grievous bodily harm. bodily harm, upon any trespasser or other person coming in contact therewith, is guilty of a misdemeanor, and shall be liable to be imprisoned in the Penitentiary for any term not exceeding three years and not less than two years, or to be imprisoned in any years and not less than two years, or to be imprisoned in any other gaol or place of confinement for any term less than two years, with or without hard labour ;---and whosoever knowand wilfully permits any such spring-gun, man-trap, or other beine which may have been set or placed in any place, then being in or afterwards coming into his possession or occupation, by some other person, to continue so set or placed shall be deemed to have set or placed such gun, trap or engine with such intent as aforesaid; Provided, that nothing in this section contained Proviso. shall extend to make it illegal to set or place any gin or trap such as may have been or may be usually set or placed with the intent of destroying vermin.

Whosoever unlawfully and maliciously puts or throws upon Placing wood, or across any railway any wood, stone, or other matter or thing, way, or reor unlawfully and maliciously takes up, removes or displaces any moving rails, rail al wfully and maliciously takes up, removes or displaces any moving rails, hill, sleeper, or other matter or thing belonging to any railway, or intent to enwhat willy and maliciously turns, moves or diverts any point, or danger pas-other willy and maliciously turns, moves or unlawfully and sengers. other machinery belonging to any railway, or unlawfully and sengers. aliciously makes or shows, hides or removes any signal or light upon upon or near to any railway, or unlawfully or maliciously does or cane of the done any other matter or thing, with intent, in any of the cases aforesaid, to endanger the safety of any person traveling or being upon such railway, is guilty of felony, and shall be hable to be imprisoned in the Penitentiary for life, or for any term bot less than two years, or to be imprisoned in any other gaol or place of confinement for any term less than two years, with or Without hard labour.

Whosoever unlawfully and maliciously throws, or causes Casting to fail or strike at, against, into or upon any engine, tender, carriage apon a raiway truck or truck used upon any railway, any wood, stone, or other matter carriage with or this or thing, with intent to injure or endanger the safety of any intent to enperson being in or upon such engine, tender, carriage or truck, or safety of any or many or truck of any person therein to the upon any other engine, tender, carriage or truck of any person therein. the of which such first-mentioned engine, tender, carriage or forms part, is guilty of felony, and shall be liable to be imprisoned in the Penitentiary for life, or for any term not less than
