Ynopsis of Canadian North-West.

Any even numbered section of Dominion Lands in Manitoba or the North-West Provinces, excepting 8 and 26, not reserved, may be homesteaded by any person, the sole head of a family, or male over 18 years of age, of 160 acres, more or less.

Application for homestead entry of inspection must be made in person by the applicant at the office of the local Agent or Sub-Agent.

An application for entry or inspection made personally at the Sub-Agent's office may be wired to the local Agent by the Sub-Agent, at the expense of the applicant, and if the land applied for is to be held until the necessary papers to complete the transaction are received by mail.

In case of "personation" the entry will be summarily cancelled and the applicant forfeit all priority of claim.

An applicant for homestead entry, and only one application for inspection will be received from an individual until that application has been disposed of.

A homesteader whose entry is in good standing, and not liable to cancellation, may, subject to the approval of the Department, relinquish it in favor of father, mother, son, daughter, brother or sister, if eligible, but to no one else, on filing declaration of abandonment.

Where an entry is summarily cancelled, or voluntarily abandoned, subsequent to institution of cancellation proceedings, the applicant for inspection will be entitled to prior right of entry.

Applicants for inspection must state in most particulars the nonstatutory in detail, and if subsequently the statement is found to be incorrect in material particulars, the applicant will lose any prior right of re-entry, should the land become vacant, or if entry has been granted it may be summarily cancelled.

SINCLAIR INDICTMENT DISMISSED.

Regina, Oct. 19.—The indictment against Sinclair is quashed by decision of the Supreme Court on banc this afternoon.
