Mr. Fisher: Mr. Speaker, can we take it from the Prime Minister's answer that the arrangements in so far as the Canada pension plan are concerned, which were negotiated with Quebec, will apply, so far as the federal government is concerned, to Ontario, if that province is willing to accept them?

Mr. Pearson: That is a very hypothetical question, Mr. Speaker. We are going ahead with our consideration of a bill which will apply to Ontario.

Right Hon. J. G. Diefenbaker (Leader of the Opposition): Arising out of the answer just given by the Prime Minister, has there been any indication from the government of Ontario that it intends to set up its own pension scheme, or has the government of Canada received any communication from provincial authorities in this connection?

Mr. Pearson: No communication regarding that course of action has been received by the federal government from the government
