ESCALATION OF COST TO MUNICIPALITIES—REQUEST FOR UNANIMOUS CONSENT TO MOVE MOTION UNDER S.O. 43

Mr. Robert McCleave (Halifax-East Hants): Mr. Speaker, pursuant to Standing Order 43 I ask the unanimous consent of the House to present a motion on a matter of urgent and pressing necessity. This urgent matter arises because the federal and provincial welfare ministers meet next week in the midst of a welfare crisis which has grown so great that some municipalities in Canada are driven to strike single unemployed men from their welfare rolls. The House has been unable to get assurances from government spokesmen that this problem will be discussed at this closed conference. I therefore move, seconded by the hon. member for Simcoe North (Mr. Rynard):

In view of the agonizing choice which municipalities in all regions of Canada must make between assuming the impossible financial burden of the unprecedented escalation of welfare costs due to the inequitable welfare cost-sharing arrangements and, on the other hand, refusing welfare payments to increasing thousands of deserving unemployed victims of the government's unemployment and inflation policies, this House urges the government to place this welfare crisis on the agenda of the federalprovincial welfare meeting next week, recommends that in addition to the federal Minister of National Health and Welfare and the provincial welfare ministers there be present those other federal government ministers who are charged with responsibilities related to welfare and employment, representatives of the Federation of Mayors and Municipalities, and representatives of the National Welfare Council, and declares that the primary objective of the conference must be to construct
