Mr. McKenzie: The Canadian dollar-

The Acting Speaker (Mr. Turner): Order, please. The Chair recognizes the hon. Parliamentary Secretary to the Minister of Finance (Mr. Martin).

Some hon. Members: Hear, hear!

Mr. Martin: Mr. Speaker, has the hon. member looked at any part of the speech of the Prime Minister (Mr. Trudeau)? Does he know where Canada stands in relation to the other 15 industrialized countries in the world?
