REQUEST GOVERNMENT REVERSE DECISION TO SELL OR CLOSE CERTAIN GRAIN ELEVATORS—MOTION UNDER S.O. 43

Mr. Ray Hnatyshyn (Saskatoon-Biggar): Mr. Speaker, I rise under the provisions of Standing Order 43, on a matter or urgent and pressing necessity.

In light of the decision of the government to sell five inland grain elevators in the prairie provinces and a port elevator at Prince Rupert, British Columbia, and in light of the fact that such decision has been made at a time when record utilization and profits are being experienced by the terminals in Saskatchewan and pitifully small offers have been received on the tenders for these elevators, and in the case of the government elevator in Saskatoon no bid at all was received, I move, seconded by the hon. member for Moose Jaw (Mr. Neil):

That this House directs the government to reverse its wrong-headed decision to sell or close the five inland grain elevators and the port elevator at Prince Rupert, British Columbia, as the sale for closing of the said elevators at this time can only have a negative effect on grain handling and transportation in western Canada.

Mr. Speaker: The presentation of such a motion at this time can be done, pursuant to Standing Order 43, only with the unanimous consent of the House. Is there unanimous consent?

POST OFFICE ACT

REQUEST FOR AMENDMENT RESPECTING RURAL ROUTE MAIL CARRIER CONTRACTS—MOTION UNDER S.O. 43

Hon. W. G. Dinsdale (Brandon-Souris): Mr. Speaker, I rise, under the provisions of Standing Order 43, on an urgent matter of public importance.

On March 17, 1978, the Postmaster General admitted in the House that rural route mail carriers, in the face of continuing inflation, are suffering because of the \$10,000 ceiling imposed on rural contracts, and promised that steps would be taken to amend the Post Office Act with a view to ending this discriminatory practice. Because of the government's failure to act, I move, seconded by the hon. member for Central Nova (Mr. MacKay):

That the Postmaster General introduce at the earliest possible opportunity an amendment to the Post Office Act designed to remedy this long-standing injustice, as promised by him and his predecessors over the past few years.
