SUPPLY AND SERVICES

CONTRACT AWARDED TO UNITED STATES CITIZEN

Mr. Jean-Guy Guilbault (Drummond): Mr. Speaker, my question is directed to the Minister of Supply and Services. Yesterday's *Citizen* reported that a two-year contract had been signed in February 1984 by the previous Government with an American who was paid exorbitant fees for his services in marketing a Canadian gold coin. Does the Minister intend to investigate the matter, since this person is under contract to other Governments and since according to a Canadian bank, experts were available in Canada?

Hon. Stewart McInnes (Minister of Supply and Services): Mr. Speaker, this particular individual is a New York broker who is working for other Governments as well as that of Canada. He signed a contract with the Canadian Government on February 1, 1984. There have been some media reports that he has done very well by the contract. We have to acknowledge that he has done so. In hindsight, we probably would not have signed the same contract today, but giving him all the credit to which he is entitled, he has done very well. He has increased the share of Canadian gold bullion from 22 per cent of the market to 64 per cent.

LETTING OF CONTRACTS

I suggest that the present administration is just as pure, or maybe a little more so, than that of the last 16 years.

SITUATION OF FARM WOMEN
