#### **GUN CONTROL**

Mr. Guy Saint-Julien (Abitibi): Mr. Speaker, I have a petition concerning firearms from people in Ottawa, Gloucester, Cornwall and Summerstown. The petitioners humbly declare that the accessibility of weapons is a critical factor in murders, accidents and suicides and that many types of weapons which are easily available in
