The industry is prepared to discuss and suggest proposals to relieve anxieties about cross-border shopping and smuggling. I urge the government to accept this invitation and to consult with the land border duty free industry toward a mutually acceptable solution.

#### WILSON NEPOOSE

Mr. Robert E. Skelly (Comox—Alberni): Wilson Nepoose spent over five years in jail for a murder conviction based on questionable evidence.

Last year the Minister of Justice, under section 690 of the Criminal Code ordered an appeal for Wilson Nepoose. In its recent decision, the Alberta Court of Appeal overturned his conviction and ordered a new trial.

The appeal court found that the evidence presented to Wilson Nepoose's original trial was deficient. In fact, it has been suggested that the evidence indicating Wilson Nepoose's guilt was, in some cases, fabricated or coerced and in other cases the Crown withheld evidence which supported his innocence.

I call on the Minister of Justice and the Solicitor General to strike a full formal inquiry into the Nepoose murder investigation to find out who fabricated, coerced or withheld evidence and recommend appropriate action.

#### SHARE GROUPS

Mr. Dave Worthy (Cariboo-Chilcotin): It was not enough last week that our closest ally and trading partner attacked us. Now it turns out that two members of the NDP have been systematically betraying and slandering the B.C. share groups that represent our resource-based communities.

Share groups are not anti-environment. Our share groups are integral elements of the communities throughout British Columbia. They represent and try to balance the interests of all stakeholders of our forests and our environment.

The membership does include people who work in the forest industry, but they also include others, mayors, teachers, businessmen and ranchers. This is truly a grassroots organization.
