PARAMEDIC APPRECIATION WEEK

AGRICULTURE

Mr. Maurice Foster (Algoma): Mr. Speaker, a few weeks ago 15,000 farmers rallied in Saskatoon to protest the policies of this government and support farm families. A week or two later a similar rally was held in Lucknow. Ontario.

Projections for farm income for this year are dramatically worse than last. A cut of over \$1 billion in net farm income is projected for this year. In Saskatchewan net farm income is projected to fall 40 per cent from 1992 levels to an average of less than \$4,000 per farm family.

Next Tuesday eight farm organizations from across Saskatchewan will make presentations to a televised hearing of the Standing Committee on Agriculture to outline the desperate situation facing farm families in that province.

I call on the government to recognize the failure of its policies and programs and provide more assistance on an urgent basis so that these farmers can survive and stay on their land.

SMALL BUSINESS

Mr. Ken James (Sarnia—Lambton): Mr. Speaker, as a small business person in my private life, I rise to laud the initiative shown by the Bank of Nova Scotia on the small business lending front.

Scotiabank appears to want to lead by example. The bank has demonstrated a much needed aggressiveness in the area that is so important to our economic prosperity. Our small businesses must have access to start-up cash and loan capital to grow and expand.

This initiative carries with it an important message to the federal government, which is that a lot can be accomplished under new management and a fresh, renewed approach.
