Townships of Brant and Elderslie, in the County of Bruce.

3. An application from the Committee for a grant of \$200, towards re-building St. James', Biddulph, was received.

The Standing Committee recommended that these be filed with the other applications, to be dealt with when the Society is in a position to make grants.

MISSION BOARD REPORT.

The Mission Board made the following

. They recommend that the Mission of Belmont, Harrietsville and Dorchester Station be put on the \$800 a year list,

from the lat of April next. 2. A letter from a Committee of St. Paul's Church, Kirkton, was laid before the Board, stating that Kirkton was unable, in conjunction with Prospect Hill, to continue to support a Clergyman as a settled Mission, and recommending that Kirkton, with other places in the neighbourhood, be formed into a travelling

The Board recommended that Kirkton, &c., be formed into a travelling Mission, so soon as the Bishop is able to appoint a Clergyman; and so when the Mission is formed the Board will recommend a financial arrangement for such Mission.

3. A letter was read from the Churchwardens of St. James', Brooke, and of the congregation at Alvinston, asking that they may be formed into a Mission.

The Board recommended that the Township of Brooke be formed into a Mission, with a grant of \$300 a year from April 1st next.

4. A letter was laid before the Board from Rev. J. Hill, asking for a grant to the Mission of Victoria, &c.

The Board recommended that a grant be made to Vittoria, &c., of \$300 a year, from February 1st, 1873.

5. An application was made by Isaac Shawnoo, chief, and the Churchwardens as Kettle Point, asking for a grant of \$50 towards the stipend of the Schoolmaster and Catechist at Kettle Point, on account of the withdrawal of the grant heretofore made by the Church Missionary Society.

The Board recommended, a grant of

\$50 a year, from October 1st, 1872.
6. Rev. H. P. Chase applied for a grant of \$50 a year towards the salary of the School-teacher at Oneida, as at present only \$150 is available, vis., \$100 from Colonial Church Society, and \$50 from

the Indians, and unless this is increased, the teacher will be obliged to leave.

The Board recommended a grant of \$50 a year.

X. Resolved,—That a grant of \$50 a year be made to the Kettle Point schoolmaster from October 1st, 1872. Carried. The sixth clause was read.

Moved by Rev. Canon Elwood, seconded

by D. J. Hughes, Esq.,-XI. Resolved,—That a grant of \$50 a year be made to the school-teacher at Oneida, Carried.

Moved by W. Grey, Esq., seconded by D. J. Hughes, Esq.,-

XII. Resolved, - That the Rev. J. G. Baylis, Col. Bourke, James Ingersoll, W. A. Sampson, and G. H. M. Johnson, Mohawk chief, be elected incorporated members

of this Society. Carried.
