an audience of fully 3,000 people gathered in the rink at Brandon, Man., on Saturday evening to hear Hon. Clifford Sifton, minister of the interior, reply to the charges made by Sir Hibbert Tupper regarding the management of Yukon affairs. Mr. Andrew Kelly acted as chairman.

He devoted aimost his entire speech to the Yukon administra-He charged that the Laurier Administration had gained power by false pledges and talse promises, and inaugurated an era of corruption, and waid: "I say this to make my case clear: This Administration has inaugurated a carnival of crime, and I will tell you the culmination; I put it to you judgment. In my hearing in the House of Commons this session I saw the culmination when Sir Wilfrid Laurier attempted to stand up as an apologist for crime.

Sir Hibbert then cited the case of Lemieux, the tather of Mr. Rodolphe Lemieux, M. P. for Gaspe, who is a member of the civil service, and who took part in his son's election under, Sir Hibbert asserted, an assuma name. Sir Hibbert continued: The Prime Minister had to admit the acts, and his plea that he attempted to make in the face of the country was that much might be forgiven Mr. emieux, because it was the act of a ather on behalf of his son. A more isgraceful statement was never made in any parliament under the British flag. (Cheers and some disturbance.) From that time down the opposition has pressed for a judi-cial inquiry into the charges then made, and many more that had followed were things that could not have happened unless Mr. Sifton had been grossly negligent. The proof came in the visit of the governor-general Dawson the other day, and there his excellency was presented with a me-morial by the citizens of Dawson which was one of the strongest indictments against the administration in that country to a representative of the crown. I did not know all the cards Mr. Sifton had up his sleeve. The rest of Sir Hibbert's speech was a repetition of his speeches on the Yukon administration made before the House of Comons.

Mr. Sifton's Reply.

The chairman's calling on Mr. Sifton to reply to Sir Hibbert Tupper was the signal for a great outburst of enthusiasm. Men jumped to their feet and cheered again and again, while flags, hats and handkerchiefs were waved all over the audience. It was one of the most enthusiastic receptions ever accorded a public man in the west. Mr. Sifton said: I have come here at considerable inconvenience. I came to Brandon some days ago, when I understood that Mr. Macdonald was about to call a public meeting; I had written to him some days in advance of the meeting and avoided other public engagements and held myself open to speak if permitted. I received no invitation to attend this meeting, and my friends informed me that I would not be allowed to speak. Some days later Mr. Macdonald's personal organ accused me of funking meeting Mr. Macdonald. I then started my own meetings, and then received telegrams to be here this evening to meet Sir Hibbert Tupper, and I said I saw no reason why I should cancel my meetings to suit him or Mr. Macdonald. However, I arranged to cancel my engagements elsewhere, and my reason for doing so is that otherwise it would have been said by the Conservatives that I was afraid to meet Sir Hibbert Tupper, and I do not propose that my friends shall have to make any apologies on my behalf in this campaign. I expected that he would have been able to say something-(c I confess that I am somewhat pointed. (Cheers.) I expected that I would have heard samething new. I have not heard anything that I have not heard five or six times before, or that has not been printed in the papers half a dozen times before, and think that while Sir Hibbert Tupper may congratulate himself upon a very large audience assembled to hear him -and I give him credit for drawing the audience—(no, no, and cheers)—I think should he come to Brandon again, will be more room next time. (Laughter.) I read his speech at Cal-gary and there is a difference in the tone of the two speeches. It is said sometimes that the presence of an opponent has a tempering effect. Sir Hibbert Tupper said I was the man he was after. (Cheers.) He has been after me a long time, and is not catching up very fast. (Laughter.)

AN INFAMOUS DOCUMENT. Before dealing with Sir Hippert Tupper's remarks I want to refer to a document that came through the mails to the electors of this constituency. It is sent out on behalf of the Conservative managers, and is the most infamdocument ever sent to an elector in Manitoba. (Hear, hear.)

(Cheers and counter cheers.) That's what it is in-tended for; the editorial page has been copied and the intention is that people reading that paper will think that the Toronto Globe is attacking the Liberal party. I say that it constitutes a falsehood, and if Mr. Macdonald does. not apologize, then he is not living up to the character he took for himself at the commencement of his campaign.

(Hear, hear.) THE TUPPER CHARGES.

Mr. Sifton, continuing, said: When Sir Hibbert Tupper made his nine hours' speech in the House of Commons he did not do what I challenged him to do. When he made his speech he said there were two kinds of charges one of a personal character, the other as to personal ability. A man may be honest, but utterly incapable; we have no right to say he is dishonest but we have a right to put him out of office. We have no right to mix up personal honesty with other mat-ters; parliamentary institutions provide for that; a man must stand up in the House of Commons and make a charge on his personal responsibility. He challenged him for the last three years to do that and he has not done it yet. (Cheers.) Tonight they heard him distinctly say that he did not know anything of the kind. That would not be satisfactory to Mr. Macdonald and his campaign managers. More unfair or more dishonest charges had never been made than those made against him regarding the administration of the Yukon, Men have been employed at the coast for the purpose of getting hold of disappointed miners who had lost all their money and often that of their friends as well, and have got them to make all sorts of statements without vindication or proof, and these have been circulated by the Conservative press. It was a systematic business on the part of certain journals to suppress all statements favorable to the gov-

If it was the truth I had not right to be a member of the government or the representative of the city of Brandon. (Hear, hear.) If it was a lie it had a right to be characterized as such. hear.) Under the British judicial system a man is considered innocent until proven guilty. I propose to prove to the satisfaction of every Conservative gentleman in this audience, including the chairman-(cheers)-Sir Hibbert Tupper-(more cheers)-and even Senator Kirchhoffer-(further cheering)se to prove that the stat made from that platform by Sir Charles Tupper was a falsehood.

On my return to Winnipeg I immediately wired Sir Charles Tupper for authority to settle this suit on the terms of the draft letter settled by us in Brandon, and I am this morning in receipt of a wire authorizing me to carry through the settlement. I am forwarding the tention. A little over a year ago Sir letter to him at Cape Ereton today Charles Tupper, the very venerable asking him to sign and return immediately, and in the meantime for the purpose of finally settling the suit I hereby undertake to obtain his signature to the letter. We may, there-fore, consider the suit settled. Yours truly, (Signed) F. H. PHIPPEN." SIR CHARLES TUPPER'S APOL-OGY.

The draft letter referred to is as fol-

'Dear Sir,-Referring to a speech made by me at Brandon on the 20th of November last, during which you ciaim I made certain damaging references to you in reference to the importation or alleged importation of liquor into the Yukon Territory, I beg to say that such speech was intended to be directed by me entirely to a discussion of public questions, and my intention was not to reflect in any way upon you personally. If any of those present took a different meaning from what I said I now beg to say that subsequent investigation has shown me that the telegram sent in your name to Mr. Sifton on the 12th of June, 1898, asking that the letter in question should be amended so as to include the importation of liquor into the Yukon, and which telegram was referred to by Mr. Sifton on the floor of the House of Commons as having been received by him from you, was not sent or authorized by you, and that you did not, directly or indirectly, in any way, through yourself or any other person, take or attempt to take liquor into the Yukon Territory under the authority of the letter given by Mr. Sifton, to which I referred in my remarks, and that you were no party, directly or indirectly, to the attempt made to dispose of the letter. I further beg to state that I have satisfied myself that there is no ground for believing that vourself or Mr. Sifton were concerned together in taking or attempting to take liquor into the Yukon Territory. I sincerely regret if anything which I said has been construed into a reflec-

tion on your character."
Mr. Sifton continued: "Those of you who were here last year and heard Sir Charles Tupper upon the platform, and heard him make that charge, and have heard the members of the Conservative party who believe it-they did not all believe it. I am glad to say-and who circulated that story all around the country, can realize the depth of humiliation of that gentleman in signing a complete, absolute refutation, (Cheers.) And if this gentleman— (turning to Sir Hibbert)—will place some of his statements in a categorical form in the same way, he will have pleasure of signing a document like this." (Enthusiastic and contin-

THE AUDIENCE OBJECTS. The storm of applause which marked the close of Mr. Sitton's address had scarcely subsided when Sir Hibbert was on his feet. This was too Tupperian for the audience, which broke out in another continued round of groans and hisses. He challenged Mr. Sifton to say that he had been under the influence of liquor when in the house. Mr. Sifton had simply called his opponents liars.

A voice—So they are.
"That was simply avoiding the question," he said. He had not taken up his (Tupper's) charges one by one, but had systematically hedged on them. It was like Mr. Sifton to introduce a lot of cheap claptrap about his getting into a libel suit, as his father had done. He was not afraid of it. He characterized as disgraceful the action of Mr. Sifton making capital out of the letter of apology sent by his father to Mr. Philp. It was throwing dirt on the conduct of a gentleman who had only acted the part of a gentleman. (Loud jeers, and a voice—"He didn't do it till he had to.") Sir Charles Tupper did not know that a certain telegram had been formal. certain telegram had been forged; Mr. Sifton had not told him. After all. Mr. Sifton had not come to the kernel of the matter. Mr. Sifton was afraid of the inquiry, and had resorted to giving statements the lie. He (Tupper) had not attacked Mr. Ogilvie's judicial character, but said there had been suspicious things in his action as judge in affairs which came so close to Mr. Sifton's character. He was reiterating his statements about the seriousness of the charges he made against Mr. Sifton and of the difficulties under which he had spoken, when some one in the back of the rink shouted: "Three cheers for Sifton!"
These were given with such heartiness that three-quarters of the audience must have joined. Sir Hibbert sat down as though he had finished, and the audience started for home. They had heard the charges that were to drive Mr. Sifton from public life forever, they had heard Mr. Sifton's reply to the charges, which had been eminently satisfactory. They did not propose to sit and listen to the abusive statements which Sir Hibbert Tupper had indicated he was quite prepared

to make, and the audience was deserting him. The chair-man's authority was hopeless when it came to an attempt to make them sit and listen to more ravings from Sir Hilbbert Tupper. The delusion which the local Conservatives had cherished concerning the speech which was to smash Sifton was expleded. The chairman came to the front of the platform and asked for three cheers for the Queen.
