

TTLE Bell BIOGRAPHIES **A**Aozart

OLFGANG AMADEUS MOZART, though but 35 years old at his death, left a name second only to Bach's. He was born in 1756 and died in 1791. He was the first "infant prodigy" of the musical world, and his career proves the necessity of having good music in the home for the making of a musician.

When the merest child, Mozart would always be found at the clavier picking out sweet little melodies. When four he was placed under a teacher and even then composed short pieces which astonished his parents and instructor. At seven he played so wonderfully that he made a concert tour of Europe. Before he was ten he had written six sonatas, one composition for full orchestra, and an oratorio. At twelve he wielded the conductor's baton. Of his many compositions the most popular are his opera, "The Magic Flute," and his "Re-quiem;" the latter sung by some friends and himself as his eyes closed in death.

As a pianist Mozart was the originator of the concert tour, and as great in his day as Paderewski in ours. But, like Bach, he was handi-capped by the instrument he used—the clavier. How wonderful had been his music if he could only have played upon






