Mr. Orlikow: Mr. Speaker, I hesitate to be as difficult as the hon. member from a Nova Scotia constituency was concerning his question as to the use of a certain Jetstar aircraft, but question No. 79 has been on the order paper since October 8. It was also on the order paper in the previous session. It has to do with the use by the Prime Minister's office of outside consultants. I do not think it should be difficult to answer, and I wonder if I could get

some indication of when the answer might be forthcoming?

- Mr. Jerome: Yes, Mr. Speaker. There have been a number of questions on the order paper involving this same general subject, the use of consultants' studies, with which there was some difficulty in making responses. We have now solved that problem and in the last few days have in fact tabled a number of responses in that general area, although not specifically to the question of the hon member. I am very optimistic that we will be able to table an answer to his specific question very soon.
- Mr. Comeau (South Western Nova): Mr. Speaker, last December a \$160 million loan fund was established to help the provinces in their programs. On February 3 I asked a question. I am sure the government has the answer. I cannot see why the government has not answered because this program has been in effect.

Mr. Jerome: I will look into it, Mr. Speaker.
