PROPOSED SUPERTANKER PORT IN ISLE VERTE REGION OF QUEBEC—REQUEST FOR ECOLOGICAL STUDIES

In view of the minister's expressed justifiable concern over dangers to the Canadian environment in the building of a supertanker port at Eastport, Maine, and in view of the recent statement by the Quebec minister of natural resources that environmental studies with regard to the building of a superport at Isle Verte, Quebec have not begun, could the minister express to the House the concern of his ministry by indicating that the department has begun ecological studies surrounding the building of the superport in Isle Verte, Quebec?

Hon. Jack Davis (Minister of the Environment): Mr. Speaker, we have already completed an environmental impact assessment on the Lorneville project in New Brunswick, and a joint investigation regarding the Canso project is under way. We are happy to join with the provinces in these kinds of appraisals at any time.

Trudeau (Prime Minister): Mr. Speaker, without going into details, I should like to tell the hon. member that, if he carefully examines the documentation submitted to the conference as well as the positions taken respectively by the Minister of Finance (Mr. Turner) and the Minister of National Health and Welfare (Mr. Lalonde), he will realize that the government's position was in fact to surrender to the provinces the taxation means which they need to finance the two programs under discussion, namely health services and post-secondary education.
