MORE AFFORDABLE HOUSING UNITS-MOTION UNDER S.O. 43

Mr. Lloyd R. Crouse (South Shore): Madam Speaker, I rise under the provisions of Standing Order 43 to move a motion of urgent and pressing necessity. In light of the fact that Statistics Canada yesterday reported that the number of people filing unemployment insurance claims was up 10 per cent over a year ago and that benefits paid were 12 per cent higher than a year ago, and in light of the budget's almost total lack of action to stimulate activity in the labour-intensive Canadianowned housing sector, I move, seconded by the hon. member for Mississauga South (Mr. Blenkarn):

That the government immediately bring in measures to enable more affordable family housing units to be built to fill the estimated required 47,000 units over 1980-81, thus simultaneously meeting both social and economic needs.
