- 4. What amount was paid by the (a) Privy Council (b) Department of the Solicitor General for legal services in connection with the Commission?

- 5. What amount was paid to (a) Professor Franks of Queen's University (b) Professor Edwards of the University of Toronto (c) Professor Friedland of the University of Toronto for the "background studies" prepared by them for the Commission?
- 6. For what reason did the Government not publish an itemized accounting of the costs of the Commission?

CBC—PRIME MINISTER'S BROADCASTS

During the period between the receipt of the Prime Minister's instruction for the granting of three 15-minute free-time appearances on CBC/Radio-Canada networks and the acquiesence in October, 1982, which senior officials of the CBC were consulted by the President of the CBC and what specific questions were put to them?

Hon. Francis Fox (Minister of Communications): I am informed by the Canadian Broadcasting Corporation as follows:

No instruction was received by the CBC from the Prime Minister's office in connection with the appearances. A request was made for air time and the request met the requirements of the policy on prime ministerial broadcasts on current issues which was established following discussions between the CBC and representatives of the federal political parties.

The President of the CBC consulted the senior officers responsible for this area of program policy, asking them questions about its history and the previous interpretations that had been given to it. The President takes full responsibili-
